**New Clubhouse Unveiled at Versailles on the Lakes Apartments**

Chicago-based RMK Management Corp. has announced the grand opening of the new 6,700- square-foot clubhouse at its award-winning Versailles on the Lakes apartment community located in Schaumburg, a northwestern Chicago suburb.

The opening of the new clubhouse marks the completion of a seven-month, \$2-million tear-down and rebuild at the community on North Plum Grove Road just south of Golf Road.

“Today’s renters are looking for luxury, not only in an apartment residence, but also in a community’s amenities, which means we must constantly improve our offerings,” said Tony Rossi Sr., president of RMK Management Corp. “With this new clubhouse, Versailles on the Lakes maintains its standing as one of the premier apartment communities in Chicago’s northwest suburbs. Inside the clubhouse at Versailles on the Lakes, residents can find a cyber café; media room with theater seating and a 123-inch TV; business center; conference room; demonstration kitchen; and fitness center. The fitness center includes cardiovascular exercise machines with built-in LCD TVs and a large window overlooking a toddler room so parents can keep an eye on their kids while they work out.

“Our goal is to provide our residents with as many conveniences as possible right in their community,” Rossi said. “With features that allow our residents to work out or host get-togethers, we are achieving that goal. We are making our residents’ lives easier and offering the chance for neighbors to spend more time together in this great new environment.”

RMK is planning gatherings for the new clubhouse, including movie nights; parties for major sporting events; and cooking demonstrations and special tastings with local chefs, Rossi noted.

In addition to the clubhouse, Versailles on the Lakes offers a whirlpool and spa and two large swimming pools, each with its own deck and bath house. There are two tennis courts available to residents, and a gazebo overlooking a central lake.

Residents at Versailles on the Lakes also have easy access to area conveniences. The community is near Woodfield Mall and is just 15 minutes from O’Hare International Airport. The neighborhood is served by Schaumburg School Districts 54 and 211.

Residences at Versailles on the Lakes range from one-bedroom/one-bath to two-bedroom/two-bath, with rents from \$820 to \$1,550 monthly. All residences include large patios or terraces; wall-to-wall carpeting; central heat and air; an eat-in kitchen with oak cabinetry; and ceramic-tiled baths with marble countertops.

To visit Versailles on the Lakes, follow Interstate 90/94 West and exit at S. Arlington Heights Road. Turn left at W. Algonquin Road/Illinois Route 62, then veer left onto Golf Road. Turn left onto S. Plum Grove Road, and the community will be down about one-quarter mile on the right.
